In exchange for participating in the SDG 17 by Louisa L. project (the "Project"), I agree as follows:

1. I represent and warrant that (i) I am not subject to any collective bargaining organization or union that would require Louisa L. to pay any fees for the rights granted herein; (ii) any statements made by me are expressions of my personal experience and Prudential has the right to attribute any such statements to me; and (iii) I have not given anyone else the exclusive right to use my image, likeness, voice, actions, statements or any materials based or derived from these items, so I am free to sign this agreement.
4. I release Louisa L., any company or person employed by or related to Louisa L., and any person or company that obtains any rights from Louisa L. described above, from all liabilities and claims, whether known or unknown, asserted or non-asserted, that relate in any way to the rights I have given to Louisa L. above or my participation in the Project including, but not limited to, those arising from or related to editorial acts, copyright, defamation, misrepresentation, faulty reproductions, violation of right of publicity or invasion of privacy.
5. I shall not make or authorize any public statement concerning this agreement, the Project or Louisa L. without the prior consent written of Louisa L. in each instance.
6. This agreement contains the entire understanding between the parties regarding the subject matter hereof, supersedes all prior understanding and may not be modified except by a writing signed by both parties. This agreement shall be construed in accordance with the laws of the State of New Jersey, without regard to any conflict of laws.
